Qualification:

President:

A person who is, or has been, or is qualified to be a District Judge.

Member:

A person who,

- (a) is of not less than thirty-five years of age; and
- (b) possesses a bachelor's degree from a recognised University; and
- (c) is a person of ability, integrity and standing, and having special knowledge and professional experience of not less than fifteen years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine.

Procedure for appointment: Appointments will be made by the State Government on the recommendation of the Selection Committee constituted under Rule 6(1) of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020.

Term of Office: For a term of four years or up to the age of sixty-five years, whichever is earlier.

Remuneration and other terms of service: As per the relevant rules in force

notified by Central/ State Government from time to time.

Duly filled up applications along with self attested copies of certificates and documents, addressed to the Secretary, Consumer Affairs Department, Government Secretariat, Thiruvananthapuram PIN 695001, must reach Government on or before January 25th, 2021
