#### **Oualification:**

For President of the District Consumer Disputes Redressal Commission: A person who,

(a) is, or has been, or is qualified to be a District Judge.

# For Member in the District Consumer Disputes Redressal Commission: A person who,

- (a) is not less than thirty five years of age;
- (b) possesses a bachelor's degree from a recognized University; and
- (c) is a person of ability, integrity and standing, and having special knowledge and professional experience of not less than ten years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine.

Procedure for appointment: Appointments will be made by the State Government on the recommendation of the Selection Committee constituted under Rule 6(1) of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020 and as per the Consumer Protection (Qualification for appointment, method of

recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Amendment Rules 2023 and as per orders dated 03-03-2023 of the Hon'ble Supreme Court in CA No.831/23.

The Selection Committee shall short list the qualified applicants on the basis of performance in a written test consisting of two papers for 100 marks each (Objective type and Descriptive type), with the qualifying marks of 50% in each paper and there shall be viva voce of 50 marks.

Term of Office: For a term of four years or up to the age of sixty five years, whichever is earlier for President/ Member of District Commission.

Remuneration and other terms of service: As per the relevant rules in force notified by State Government from time to time.

- b) Copy of document to prove date of birth
- c) Copy of document to prove Educational Qualification
- d) Copy of document to prove professional experience
- e) Copy of service certificate for serving/ retired candidates.

Applications sent as soft copies will not be entertained.

Incomplete applications /applications without the copies of necessary documents or received after the last date of receipt of application will be summarily rejected.
